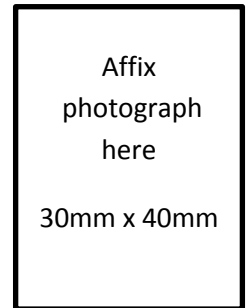
PLEASE REFER TO THE DOCUMENT LIST, CHECKLIST AND GUIDELINES BEFORE COMPLETING THIS FORM

This form is to be completed in English by a duly licensed Lawyer, Notary Public, a Maltese Consular or Diplomatic Officer or a Senior Officer of the Concessionaire who must have seen the original passport as evidence of identification. This individual must certify the photograph to be a true likeness and the signature to be the true signature of the person whose details appear on this form.

In the case of a Notary or Lawyer, certification must be authenticated by an Apostille according to the Hague Convention of 5 October 1961 Abolishing the Requirement of Legalization for Foreign Public Documents; or validation of the certificate of the lawyer or notary public by the appropriate government department in the case of a jurisdiction that is not a party to that Convention; or validation of the certificate by a Maltese consular or diplomatic representation in the case of a jurisdiction that is not party to that Convention.

The certification should be made by signature and stamp or seal in Section B.

Please affix one photograph of yourself (or the minor concerned, as the case may be) taken within the past 6 months in the box on the right. Each photograph should be approximately 30mm x 40mm in size and must be attached to this form in a way that it cannot be removed without tearing the photograph or the form.
